- ____ Orientation is a mandatory full-day retreat in January 2018. (Tentative date is January 17, 2018.)
- ____ Participants are expected to attend each of the ten sessions (January – December) and the class project discussion. (Tentative date is February 28, 2017.) All sessions are from approximately 8:00 a.m. to 4:30 p.m. and typically take place on the third Wednesday of the month (meals included).
- ____ A maximum of only two absences are allowed per year. Leaving early and arriving late will count as an absence.
- ____ Participants are expected to arrive on time and stay for the entire day.
- ____ Participants are expected to silence cell phones during the session and wait to conduct their business during breaks or at lunch.
- ____ Handheld devices and tablets may only be used for taking notes during the session.
- ____ Complete all outside assignments, including but not limited to the following:
 - attending three of the five required meetings from the following list: Round Rock City Council, Round Rock Planning & Zoning Committee, Round Rock School Board, Williamson County Commissioners Court, Round Rock Chamber Board; and,
 - completing 20 hours of community service (typically as part of a group service project).
- ____ Agree to represent community, business, and the chamber in a professional manner at all times.
- ____ Tuition is due by January 10, 2018. No refunds will be made after the first class.
